Sub: Extension of the tenures Managing Committees /Ad-hoc Committees Administrators of recognised Secondary Schools in the two districts – Kolkata and South 24-Parganas in West Bengal.

The Board issued Circular No. N/S/153 dated 16.11.2011 for postponement of election for constitution/reconstitution of the Managing Committees of recognised Secondary Schools (aided and Unaided) in Kolkata and South 24-Parganas districts in West Bengal in view of enforcement of the Model Code of Conduct for the Bye-election in the Dakshin Kolkata Parliamentary Constituency involving he said two districts and consequently the election in the concerned districts remained suspended upto the date of declaration of the result of Bye-election.

As the new academic session will start from 1st January, 2012 and the process of election for constitution/reconstitution of the Managing Committee shall not commence before 16th March, 2012, the President, West Bengal Board of Secondary Education, in exercise of the powers conferred by Sub Sec. 2 of Section 28 of the W.B.B.S.E. Act., 1963 as amended read with Rule 8(2) and Rule 12 of the Rules for Management of Recognised Non Govt. Institutions (aided and unaided) 1969 as amended has been pleased to grant extension of tenure of the Managing Committees/Ad-hoc Committees/Administrators of Non Govt. Recognised (aided and unaided) Secondary Schools upto **30th June, 2012** or till completion of constitution/reconstitution of the Managing Committees whichever is earlier under the following circumstances and/ or conditions:-


- (1) Where the tenure of the Managing Committees/Ad-hoc Committees/Administrators is valid upto 31-12-2011 and its tenure will expire after 31-12-2011 and the election for constitution/reconstitution of Managing Committee was not held.
- (2) The election process for constitution/reconstitution of the Managing Committee shall commence after 15th March, 2012 and the date of election under the category of Guardians shall be fixed by 30th April 2012.
- (3) This Circular will not be applicable to the cases where the tenure of Managing Committees/Ad-hoc Committees/Administrators expired before 31.12.2011.

The Board however, reserves the right to appoint Administrator/Ad-hoc Committee where the same would be the necessary for administrative reasons.

The above Circular is not applicable where any contrary order of the Hon'ble Court prevails.
